**HIGHER EDUCATION ACT, 1997
(ACT No. 101 of 1997)****AMENDMENT OF THE TECHNIKON WITWATERSRAND**

The Technikon Witwatersrand has made the amendment to the Statute set out in the Schedule hereto, in accordance with section 32 of the Higher Education Act, 1997 (Act No. 101 of 1997), which is, in terms of the provisions of section 33 of the said Act, hereby published with the approval of the Minister of Education and which comes into operation on the date of this publication.

SCHEDULE**1. General explanatory note:**

2. *In this Schedule the expression "the Statute" means the Statute of the Technikon Witwatersrand promulgated by Government Gazette No 20245, Government Notice No. 817 of 24 June 1999.*

3. *The Statute is hereby amended by the addition of the following paragraphs:*

"TRANSITIONAL PROVISIONS"**Council**

77. (1) Notwithstanding paragraph 4, a person who immediately before 30 June 2003 serves as an appointed or elected member of the council under paragraphs 3(1)(d), 3(1)(e), 3(1)(f), 3(1)(g), 3(1)(h), 3(1)(i), 3(1)(j), 3(1)(k) or 3(1)(l), continues to serve on the council until the establishment of an interim council as contemplated in section 23 of the Act.

(2) A member of the council who serves as chairperson or vice-chairperson immediately before 30 June 2003 continues to serve in that capacity until the establishment of the interim council as contemplated in section 23 of the Act.

Senate

78. Notwithstanding paragraph 22, a person who immediately before 30 June 2003 serves as an appointed or elected member of the senate under paragraphs

21(l), 21(m), 21(n) or 21(o), continues to serve on the until the establishment of an interim council as contemplated in section 23 of the Act.

Institutional Forum

79. (1) Notwithstanding paragraph 31, a person who immediately before 30 June 2003 serves as an appointed or elected member of the institutional forum under paragraphs 30(e), 30(f), 30(g), 30(h) or 30(i), continues to serve on the institutional forum until the establishment of an interim council as contemplated in section 23 of the Act.

(2) A member of the institutional forum who serves as chairperson or vice-chairperson immediately before 30 June 2003 continues to serve in that capacity until the establishment of the interim council as contemplated in section 23 of the Act."
