**ESTABLISHMENT OF THE PROFESSIONAL BOARD FOR AYURVEDA, CHINESE
MEDICINE AND ACUPUNCTURE AND UNANI TIBB UNDER THE ALLIED HEALTH
PROFESSIONS ACT, 1982 (ACT 63 OF 1982)**
